CONDITIONS:

1. The school should start on the basis of permanent unaided institution. The education department will not sanction grant or any other financial aid to the school.
2. The school should establish all the facilities such as own/ rented school building with fresh air, drinking water, separate toilets for girls and boys, playground, teaching equipments, , non teaching equipments, sports equipments, laboratory likewise.
3. The school should appoint only trained teachers. The salary and other expenses relating to this should bear only by the management itself.
4. The school should follow the syllabus prescribed by the education department. The method of teaching and conducting the examinations will be as per the norms of the concerned department.
5. The permission which is provided to the school should not be problematic to other nearby authorized schools.

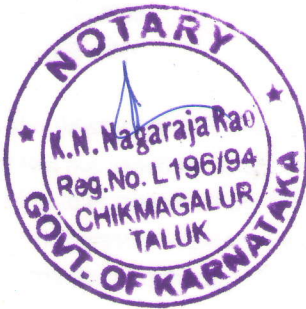
